

# Privacy Policy for PaceVault

## 1 Introduction

At PaceVault, I am committed to protecting your privacy. This Privacy Policy explains how I collect, use, disclose, and safeguard your information when you use my website and services at <https://pacevault.app>. By using PaceVault, you consent to the practices described in this policy.

I, Andreas Claesson, operate PaceVault and am based in Sweden. I may update this policy from time to time. The updated version will be posted at <https://pacevault.app/privacy>, and your continued use of the platform constitutes acceptance of the changes.

## 2 Information We Collect

I collect the following types of information:

### 2.1 Personal Information

When you create an account, I collect:

- Your name
- Email address
- Username

### 2.2 User-Generated Content

I collect content you upload, such as:

- Speedruns and split times
- Comments and messages

### 2.3 Usage Data

I automatically collect information about your interaction with PaceVault, including:

- IP address
- Browser type and version
- Pages visited and time spent
- Device information

### 3 How We Use Your Information

I use your information to:

- Provide and improve my services, such as displaying your speedruns and rankings.
- Communicate with you, including sending account-related notifications.
- Analyze usage trends to enhance user experience.
- Prevent fraud and enforce my Terms of Service, available at <https://pacevault.app/terms>.

### 4 Legal Basis for Processing (GDPR)

As PaceVault operates in Sweden, I comply with the General Data Protection Regulation (GDPR). I process your personal data based on the following legal grounds:

- **Consent:** When you create an account or upload content, you consent to the processing of your data.
- **Legitimate Interests:** I process usage data to improve my services and ensure the platforms security.
- **Legal Obligations:** I may process data to comply with legal requirements, such as tax or reporting obligations.

### 5 Sharing Your Information

I do not sell your personal information. I may share your information in the following cases:

- With your consent, such as when you choose to make your runs public.
- With service providers who assist me in operating the platform (e.g., hosting providers), under strict confidentiality agreements.
- To comply with legal obligations, such as responding to a court order.
- To protect the rights, safety, or property of PaceVault or others.

### 6 Data Retention

I retain your personal information for as long as your account is active or as needed to provide my services. If you delete your account, I may retain certain data for a period to comply with legal obligations or for legitimate business purposes, such as analytics, in accordance with GDPR requirements.

### 7 Your Rights

Under GDPR and Swedish law, you have the following rights regarding your personal information:

- Access and obtain a copy of your data.
- Request correction of inaccurate data.
- Request deletion of your data (right to be forgotten).
- Object to or restrict certain types of processing.
- Data portability to receive your data in a structured format.

## **8 Cookies**

I use cookies to enhance your experience on PaceVault. Cookies help me remember your preferences, track usage, and serve relevant content. You can manage cookie preferences through your browser settings, but disabling cookies may affect the functionality of my platform.

## **9 Security**

I implement reasonable measures to protect your information from unauthorized access, use, or disclosure. However, no method of transmission over the internet is completely secure, and I cannot guarantee absolute security.

## **10 Childrens Privacy**

PaceVault is not intended for children under 13 years of age. I do not knowingly collect personal information from children under 13. If I learn that I have collected such information, I will delete it promptly.

## **11 International Data Transfers**

PaceVault operates in Sweden, and your information is primarily processed within the European Economic Area (EEA). If your data is transferred outside the EEA, I will ensure appropriate safeguards are in place, such as Standard Contractual Clauses, to protect your data in accordance with GDPR.
