

Terms of Service for PaceVault

1 Introduction

Welcome to PaceVault, a platform dedicated to speedrunners, accessible at <https://pacevault.app>. These Terms of Service govern your use of our website and services. By accessing or using PaceVault, you agree to be bound by these terms. If you do not agree, please do not use our services.

PaceVault is operated by Andreas Claesson, an individual based in Sweden. I may update these terms from time to time, and the updated version will be effective upon posting at <https://pacevault.app/terms>. Your continued use of the platform constitutes acceptance of the updated terms.

2 Eligibility

To use PaceVault, you must be at least 13 years of age. If you are under 18, you must have the consent of a parent or legal guardian to use our services. By using PaceVault, you represent and warrant that you meet these eligibility requirements.

3 User Accounts

To access certain features, you must create an account. You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account. You agree to provide accurate and complete information during registration and to update your information as necessary.

You may not share your account with others or use another users account without permission. If you suspect unauthorized use of your account, please notify me immediately at support@pacevault.app.

4 User Conduct

You agree to use PaceVault in a manner that is lawful, respectful, and consistent with our community standards. Prohibited activities include, but are not limited to:

- Posting or sharing content that is illegal, harmful, threatening, abusive, or defamatory.
- Engaging in cheating, hacking, or other activities that manipulate run times or rankings.
- Using automated scripts or bots to interact with the platform without my permission.
- Impersonating another person or entity.
- Harassing or bullying other users.

I reserve the right to suspend or terminate accounts that violate these terms, at my sole discretion.

5 User Content

By uploading speedruns, splits, or other content to PaceVault, you grant me a worldwide, non-exclusive, royalty-free license to use, display, and distribute your content on my platform. You retain ownership of your content, but you agree that I may use it to provide and promote my services.

You represent and warrant that your content does not infringe on the rights of any third party, including intellectual property rights. I may remove content that violates these terms or applicable laws.

6 Intellectual Property

All content on PaceVault, including the logo, design, and software, is the property of Andreas Claesson or its licensors and is protected by copyright and trademark laws. You may not reproduce, distribute, or create derivative works from my content without my express written permission.

7 Termination

I may terminate or suspend your access to PaceVault at any time, with or without cause, and with or without notice. Upon termination, your right to use the platform will cease immediately, and I may delete your account and associated data.
